DECREE OF ADOPTION

The matter came before this Court for hearing on the ___ day of _____, 20___, on the Petition for Adoption filed by the Petitioners, (*first petitioner's name*) _____ and (*second petitioner's name*) _____. The Petitioners appeared before the Court personally. The Court is satisfied that all required consents to adoption have been filed with the Court. The Court has considered and examined the consents to adoption and all other documents executed and filed herein and finds them in all respects proper. The Court has (*check one*)

IT IS THEREFORE ORDERED that the Petitioners, (*first petitioner's name*) _____ and (*second petitioner's name*) _____ are declared the legal and adoptive parents of the following child(ren):

IT IS FURTHER ORDERED that if one of the Petitioner has existing parental rights to the child(ren), those rights shall remain unaffected.

IT IS FURTHER ORDERED that the minor child(ren)'s names shall be changed as follows:

IT IS FURTHER ORDERED that any other parent named on the child(ren)'s birth certificates shall be removed, and Petitioners' names shall appear on the birth certificate as the only parents to the child(ren).

IT IS FURTHER ORDERED that the minor child(ren) shall henceforth be regarded and treated as Petitioner's natural child(ren) and have all the lawful rights as his/her own child(ren), including the rights of support, protection and inheritance.
